



MASTERCLASS ANACAPRI 2023

TERMS AND CONDITIONS

The Masterclass will take place according to the following rules:

- Students may apply as Active students or Listeners.
- Every course will start with a minimum of 5 applications
- Courses are:
 - violin
 - viola
 - piano
 - cello
 - trombone
 - clarinet
- There is no age limit for participation
- The schedule will be set up to suit the needs of each professor and his/her work with students
- Lessons per student or groups will be four, one hour duration approx. every two days.
- Active students can attend every course unit of the Masterclass as listeners
- Students Listeners will have access to all the lessons of any course
- The dates of arrival and expected departure must be indicated clearly on the registration form. In absence of this information, the lessons scheduled by the organization and not attended will not be replaced or refunded.
- The repertoire of the courses units of study will be agreed at the beginning of the course with Professors.
- The number of participants is limited. Registrations will be considered according to the date when they are received.
- The complete repertoire must be submitted in the enrollment phase (using the text area in the registration form or in attachment).
- Students are required to bring musical scores, parts and piano arrangements of the program they intend to play.
- Students are invited to send the scores for piano accompanists by June 1st 2023.



COURSE DURATION

The courses will be held from 12 July to 25 July 2023.

If requested by students in accordance with teachers, the lessons may be concentrated in shorter periods. July 12th and July 25th are supposed to be arrival and departure days without activities.

CONCERTS

A concert with Professors will be organized during the Masterclass (tentative date July 21st). Appropriate suites and dresses are required for all performances.

REGISTRATION

The registrations of the students will have to take place by **July 1st, 2023, no further**. Students are invited to fulfill the online form on www.concertato.com site.

The registration will be valid only if it is completed in all its parts, including:

1. **Two-sided photocopy of a valid ID or passport**
2. **Copy of the down payment receipt, registration fee**
3. **Curriculum vitae**
4. **Copy of the payment receipt, total**
5. **Medical insurance with COVID-19 coverage for non Italian resident**
6. **Copies of the parts for piano accompanists**

The following documents can be uploaded in the online form in the site www.concertato.com.

1. **Two-sided photocopy of a valid ID or passport**
2. **Copy of the payment receipt, registration fee**
3. **Curriculum vitae**
4. **Copies of the parts for piano accompanists**

The remaining documents must be sent to the management by July 1st, 2023:

1. **Copy of the payment receipt, final balance**
2. **Medical insurance with COVID-19 coverage for non Italian resident**

In case of missing delivery, the registration cannot be considered valid and will be discarded. The medical insurance is mandatory to cover all the risks related to the current pandemic status.

ADMISSIONS

The organization reserves the right to declare ineligible candidates due to incomplete or insufficient documentation.

Not admitted students may attend courses as Listeners.

Listeners will have access to all courses.

REGISTRATION FEES

- Active students: € 450,00
- Ensembles (duo, trio etc.): € 250,00 each component of ensemble
- Listeners: € 100.00 (entry fee)
- Daily entrance for Listeners: € 20.00 per entrance

Note for ensembles: Each member of an ensemble has to carry out an active separate application for full application rate € 250,00 (registration fee € 150,00 included)

ORGANIZATION AND LOGISTIC

The costs do not include accommodation, meals and transfers.

There will also be low costs menus available in selected restaurants in the town of Anacapri.

In case, the reservation assistance must be requested as soon as possible, indicating the dates of arrival and departure.

RULES FOR FOREIGNERS IN ITALY

The entrance to Italy is subject to applicable laws. The failure to obtain a residence permit, a visa or the compulsory sanitary documentation does not automatically grant the refund of the paid amount.

COVID-19 pandemic health situation

The activities of the Masterclass will take place in full compliance with the health regulations in force at the time.

Participants in the Masterclass are required to strictly comply with the rules and obligations imposed by the health authorities (for example, if applicable, the obligation to wear masks and sanitize hands and face).

In any case, it is advisable to inquire about the norms in force at the date of the Masterclass and to strictly follow the health guidelines of the Italian government and the Campania Region to reduce the risks associated with the pandemic and comply with the law.

For students not resident in Italy, a health insurance with coverage of risks related to the COVID-19 pandemic is mandatory and must be sent at the same time as enrollment is completed.

For medical assistance, on the basis of international agreements, foreign students from European Community states are required in any case to provide form E / 111 at the same time as health insurance. Students from non-EU countries must submit health insurance to the organization.

The Masterclass organization is not responsible for sanitary costs that should arise for participants in any moment of the event.



THE MASTERCLASS INCLUDES

- Four lessons of 60 minutes
- Performances during the week and student concerts at the end of Masterclass are planned;
- If Active student, it is possible to listen as Auditor all other courses of the Masterclass
- Professors Concert
- Out-the-box labs, improvisation sessions and stage management lab
- Yoga class and morning walks
- Usage of available instruments during the Masterclass

THE MASTERCLASS DOES NOT INCLUDE

- Transfers (flights, rail or ship routes to reach Capri)
- Transfers within the territory of Capri
- Accommodation and food
- Anything not specified in "The Masterclass includes" paragraph

WITHDRAWALS

Active students:

- The registration fee is never refundable
- In case of withdrawal by July 1st, 2023, 50% of the lessons costs will be refunded, minus the costs of bank transfer and management.
- After July 1st, 2023 you will not be refunded.
- Listeners fee is not refundable.
